1. Product and Distributor information

Recommended use: Fertilizer supplement

2. Hazards Identification:

This product contains soy, adverse reaction may occur in sensitive persons.

3. Composition/Information on ingredients

Plant derived 80% Amino acid powder; NPK:14-0-0, CAS# 68607-88-5 and 68308-36-1

4. First-aid measurements

Eye contact: Flush eyes with copious amounts of water for at least 15 minutes. Assure adequate flushing of eyes by separating eyelids with fingers. Obtain medical attention immediately.

Skin contact: Flush skin with plenty of soap and water for at least 15 minutes while removing contaminated clothing and shoes. Get medical aid if irritation develops or persists. Wash clothing before reuse.

Inhalation: Remove from exposure to fresh air immediately. If not breathing, give artificial respiration. If breathing is difficult, give oxygen. Get medical aid if cough or other symptoms appear.

Ingestion: Never give anything by mouth to an unconscious person. Get medical aid. Do NOT induce vomiting. If conscious and alert, rinse mouth and drink 2-4 cupfuls of milk or water.

5. Fire-Fighting Measurements

Wear a self-contained breathing apparatus in pressure-demand, MSHA/NIOSH (approved or equivalent), and full protective gear. During a fire, irritating and highly toxic gases may be generated by thermal decomposition or combustion.

Extinguishing media: Water, CO₂.

6. Accidental Release Measurements

When dusts are generated, use personal protective wears: dust filter, goggles, gloves and protective clothing.

Environmental precautions: No ecological problems are to be expected.

7. Handling and Storage

Handling: Wash thoroughly after handling.

Wash hands before eating.

Remove contaminated clothing and wash before reuse. Use with adequate ventilation. Minimize dust generation and accumulation. Avoid breathing dust, vapor, mist, or gas. Avoid contact with eyes, skin, and clothing. Keep container tightly closed. Avoid ingestion and inhalation.

Storage: Keep container closed when not in use.

Store in a tightly closed container.

Store in a cool, dry, well-ventilated area away from incompatible substances.

Store protected from moisture.
